3 **MINUTES**

*i The minutes of the Mere Parish Council meeting held on Monday 13<sup>th</sup> September, 2021 were proposed by Cllr Duncalf and seconded by Cllr Newnes to be a true record. All agreed.*

*Cllr Wright declared a **Personal Interest** for **Hoo Green Lane**.  
Cllr Wright declared a **Disclosable Pecuniary** interest regarding **HS2**.*

5 **MATTERS ARISING**

*It was agreed all matters arising from the previous minutes are covered under the agenda headings.*

6 **POLICE REPORT**

*PCSO Emma Darroch and PC Lawrence Price had been invited to attend this meeting or, if unable to attend to forward a report. No response has been received from either.*

7 **HS2**

*Nothing to report.*

8 **B5569**

*Cllr Newnes gave a report after having attended a site meeting with Esther McVey MP and her secretary on the 24<sup>th</sup> September. As a result of this meeting Esther McVey will be writing to Cheshire East Council again, to chase up items which have still not been completed. In particular the where about of the 'pot of money' Mr Skates said is set aside for the B5569?*

*An e-mail has been received from Erin Cherneski who lives on Chester Road voicing concern that it is only a matter of time before an accident occurs on the B5569.*

*The Clerk to reply stating Mere Parish Council has asked Cheshire East Council for two-way signs at either end of the B5569/Chester Road. This is one of the items Esther McVey will be following up.*

9 **MANCHESTER AIRPORT**

*Cllr Reynolds gave a report after attended a zoom meeting on the 15<sup>th</sup> October:*

- *From 22<sup>nd</sup> October two Covid tests will be lateral flow with a charging cap of £25.*
- *The airports climate change aim is for net zero by 2050. This to be achieved by various means for example, sustainable airline fuels in three to four years, aircraft to be more fuel efficient by 15%., the use of hydrogen powered aircraft. There will be a global agreement with IATA to try and achieve this.*
- *A government body is to be established known as The Jet Zero Council.*
- *Airspace = Iccan is discontinued but CAP1616 is continuing. Now at stage two of the seven stage, fourteen steps.*

*Cllr Walker will be attending a session with the airport on the 17<sup>th</sup> November at 18hrs to 19.30hrs. The Clerk to book this.*

10 **WINTERBOTTOM LANE AND HOO GREEN LANE**

*Cllr Parkinson had forwarded an e-mail to the Clerk which she had received from Josh Holden, Cheshire East Council Highways Team. It stated he has raised two dig up jobs. One for Winterbottom Lane and one for Hoo Green Lane. He also states that he was not aware there were any issues until Cllr Parkinson submitted two enquiries on line. He also states that the jetting has identified further works to be done. In both cases the area needs to be dug for the repair to take place. He has given them a score and they will be placed onto the future scheme list. No time scale has been given for this work.*

11 **LITTER BINS**

*Two bins have appeared within the parish. One sited by the Mere Golf Club and Spa and the other opposite the BP garage on the B5569.*

*Cllr Finch informed the council Cllr Parkinson had telephoned him asking where within the parish Mere Parish Council wished the bins to be sited. Cllr Finch suggested the above two sites.*

*The Clerk to contact Cllr Parkinson asking her to confirm that the two bins are the ones she spoke to Cllr Finch about and also is it possible to have a third bin located near the junction of the A50 and Mereside Road?*
