ACTIONS

1 MINUTES

The minutes of the previous Mere Parish Council meeting held on Monday 21st October were proposed by Cllr Duncalf and seconded by Cllr Reynolds to be a true and correct record. All agreed.

2 **DECLARATION OF INTERESTS**

- Cllr Wright and Cllr Norcott declared an interest regarding HS2 listed on the agenda.
- Cllr Walker declared an interest regarding Clamhunger Lane listed on the agenda. ii

3 MATTERS ARISING

It was agreed that all matters arising from the previous meetings minutes are covered under the agenda headings.

4 POLICE REPORT

PCSO Emma Darroch has forwarded the following report:

"There have been no burglaries, no theft from motor vehicles and no theft of motor vehicles within Mere."

Rural Watch Meeting – 17th September – Cllr Norcott reported that there was a lady talking about cybercrime and it was very interesting.

Mr Skates commented that he will look to see if Cheshire East Council has any information about cybercrime and if so he will forward it to the Clerk.

5 **HS2**

The next IAG meeting should have been held on the 5th December but had been cancelled due to the pre-election period. It will be re-arranged in January 2020.

6 **B5569**

Mr Skates reported as follows:

- *Hedges* Having looked at the hedges he confirmed the majority are the adjacent land owners responsibility. The section which is Cheshire East Council's responsibility has now been cut.
- 2 Flooding In Service Road Off The B5569 – Mr Skates has visited the site and spoken to a local resident about the issue. He agrees there is a drain which keeps filling with leaves. Highways England will be carrying out more surveys. Mr Skates will look at the results and try to resolve the issue with the possible aid of cameras.

- 3 Single Lane Carriageway Signs Mr Skates stated that he was not aware Mere PC wanted two signs (One each end of the B5569). He agreed to look into having them put up. Also a third one at the exit of The Mere but he will get back to us about this one.
- Kerbs The broken kerbs have now all been repaired.
 Cllr Norcott stated that there are still some which have not been repaired.
 Cllr Duncalf commented that the day after the kerb in front of the cenotaph was repaired it was broken again by a lorry.
 Mr Skates said he will check that all have been repaired.
- 5 The Bunds Mr Skates stated that Ansa have swept or at least are due to any day. He will contact them again about road sweeping.

 The area by the Swan is to be redone by Highways England.

Cllr Wright asked about replacing the missing "Welcome to Mere" sign on the B5569 as you enter Mere from Tabley? Mr Skates agreed to look into this.

Cllr Newnes reported that the road surface is already wearing. Mr Skates agreed to look into this.

Cllr Norcott raised the point that Northbound traffic on the B5569 seeing the sign indicating that for Northwich (A556 (S)) to turn right at MereCorner is incorrect.

Mr Skates said he will look at this when he leaves this evening.

Mr Skates stated that Cheshire east Council have about another £30,000 to spend in the next Six months on issues relating to the B5569/A556.

SPEED LIMIT

Mr Skates reported that a speed review has been conducted and the result is they advise a 50mph speed limit on the B5569. However, Simon Skates is trying to get a 40mph speed limit.

The Clerk has spoken with Matt Wallton but he only confirmed that the current speed limit on the B5569 is 30mph. Also, as mentioned by Mr Skates he informed us that Cheshire East Council is trying to have the speed limit increased to 40mph. This is an on-going situation.

The Clerk asked if the police spot a driver travelling over 30mph would they be prosecuted at this current time? To which he replied he will need to speak with the Chief Inspector and then get back to the Clerk.

Cllr Reynolds asked about flashing signs which are activated when motorists travel above the speed limit, to be positioned along the B5569.

Mr Skates asked the council to think about where on the road we wish them to be located and to inform him accordingly.

The Chairman thanked Mr Skates for attending the meeting. Mr Skates then left the meeting at approximately 9pm.

7 **A556, BY-PASS**

Cllr Norcott confirmed that the fencing previously reported damaged by a car has now been repaired.

8 FENCING AT THE END OF THE MERE

The Forestry Commission have confirmed that they do not manage any land in our area. Cllr Parkinson asked for the reply from the Forestry Commission to be forwarded to her and she will look into this for us.
